CASS COUNTY BOARD MEETING

December 11, 2017

The Cass County Board met in the Courthouse, in the Court Room, on Monday, December 11, 2017 at the hour of 7:00 P.M.

The meeting was called to order by Chairman Parish, who directed the Clerk to call roll.

Roll Call:

As a result of the roll call the Clerk states that all board members are present except for board members Lynn and Wessel.

Chairman Parish states there is a quorum.

Chairman Parish now leads the board in the pledge of allegiance.

Chairman Parish then opens the floor to public comment.

David Ballance, resident of Bluff Springs, voices his concerns regarding board member Eva Lynn's attendance at the county board meetings. Ballance states Lynn has been residing in Mt. Sterling since February and has been absent for several board meetings.

Chairman Parish notes Lynn is recovering in a nursing home. She maintains her legal residence in Cass County and, as a duly elected member of the county board, may only be removed from the board if she changes her legal residence, is declared incompetent by the State's Attorney, or resigns from her position.

Ballance remarks by the time someone is elected to fill Lynn's position it will have been almost two years the board district has had diminished representation. Ballance questions whether Lynn's seat is necessary if the district can go without full representation for 21 months.

Parish states the board membership is set by statute and based on population. Although the district may have diminished representation with Lynn's absence, it has the representation of the other three board members in that district.

The Clerk next reads the minutes from the November 13, 2017 Cass County Board Meeting.

Noe makes a motion to approve the minutes and Merriman seconds the motion. The vote is by acclamation and declared carried.

The Chairman directs the Clerk to read the Correspondence.

There being no action taken the correspondence is ordered filed.

Chairman Parish next calls for reports from the standing committees:

Clerk Wessel, reporting for the Courthouse and Jail committee, reports the committee met on December 7th and approved all bills as presented.

Hagloch reports the Road and Bridge committee met on December $4^{\rm th}$ and approved all bills.

Merriman, Chairman of the Public Safety, Environment and Housing Committee, reports the committee met November 27th. Merriman reports Animal Control met November 30th. There were 12 dogs picked up, 8 returned to their owners, 1 adopted and 3 were euthanized.

Merriman, reporting for Cass Rural Water, reports the committee met November 21st.

Brannan, reporting for the Housing Committee, reports the committee met November 16th. There was a fire at Riverside Apartments. There will be no meeting held in December.

Brannan, reporting for the Health Board, reports the committee met November 29th. Brannan reports there are no TB cases in Cass County at this time. The Hospice workers and new employees will be tested.

Merriman, reporting for the Supervisor of Assessment's Committee, reports the committee met November 20th. The annual assessors meeting is scheduled for December 18th at 6:00. Terri Cooper has picked up nearly \$2.4 million in new assessments.

Hagloch, reporting for the E-9-1-1 Committee, reports the committee met November 27^{th} and approved all bills.

Schaefer, reporting for Arenzville Rural Water, reports the committee met November 21st. Kirk Rawlins originally declined water service for a small subdivision but is interested in obtaining service now. Schaefer mentions there is no funding for the addition but the committee is willing to negotiate with Rawlins.

Schaefer, reporting for the Mental Health Board, reports the committee met November 15th. The Mental Health facility hosted a free Thanksgiving dinner.

The Board next moves on to new business.

The Clerk next presents the Resolution for the Budget Transfer of Various Funds and Departments. A motion to approve the resolution is made by Starkey and seconded by Noe. The vote is by acclamation and declared carried.

The Clerk next presents the Anticipation Warrant. A motion to approve the Anticipation Warrant is made by Barnett and seconded by Douglass. The vote is by acclamation and declared carried.

Tim Icenogle, Cass County Highway Engineer, presents the Cass County Highway Department Inventory. A motion to receive the inventory is made by Merriman and seconded by Hagloch. The vote is by acclamation and declared carried.

Icenogle next presents the Resolution Reapportioning Funds within the County Highway Fund. A motion to approve the resolution is made by Merriman and seconded by Starkey. The vote is by acclamation and declared carried.

Icenogle next presents the Motor Fuel Tax Maintenance Resolution. A motion to approve the resolution is made by Barnett and seconded by Schaefer. The vote is by acclamation and declared carried.

Icenogle next presents the County Engineer Salary Resolution. A motion to approve the resolution is made by Douglass and seconded by Schaefer. The vote is by acclamation and declared carried.

Icenogle then presents the Agreement for the County Engineer Salary. A motion to approve the agreement is made by Brannan and seconded by Merriman. The vote is by acclamation and declared carried.

The Clerk then presents the Resolution Extending Stoplight Liquor's Sale Hours for December 24, 2017 and December 31, 2017. Chairman Parish notes the Liquor Control Commission recommends approving the resolution. A motion to approve the resolution is made by Douglass and seconded by Brannan. The vote is by acclamation and declared carried.

The Clerk next presents the States Attorney Appellate Prosecutor Resolution. A motion to approve the resolution is made by Hagloch and seconded by Noe. The vote is by acclamation and declared carried.

The Clerk next presents the monthly reports for the Sheriff, Treasurer, Zoning Officer, Circuit Clerk, County Clerk, Death Examiner, Maintenance Engineer, and State's Attorney. A motion to receive the reports is made by Brannan and seconded by Barnett. The vote is by acclamation and declared carried.

The Clerk next presents the semi-annual reports for the County Clerk, Treasurer, and Sheriff. The Clerk notes the Circuit Clerk's semi-annual report will be presented at the next meeting. A motion to receive the reports is made by Douglass and seconded by Merriman. The vote is by acclamation and declared carried.

The approval of claims is next presented. A motion to approve the claims is made by Hagloch and seconded by Noe. Chairman Parish directs the Clerk to call roll.
