

## CASS COUNTY NOTICE OF BOARD OF ZONING APPEALS HEARING

Notice is given that a request for a Special Use Permit has been filed with Cass County. The Cass County Board of Zoning Appeals has scheduled a public hearing on this request to be held on the 2nd of July 2020 at 7:00p.m. This hearing will be held at the Beardstown Middle/High School auditorium, located at 500 E 15th St, Beardstown, Illinois 62618. Due to the COVID-19 pandemic, in the interest of public safety and pursuant to restrictions on public gatherings in effect at the time of the meeting, the number of persons who may attend in person will be limited and the meeting may be changed to a remote-access only meeting. This meeting may be continued and reconvened at a later date without further notice provided that (1) it is reconvened within 24 hours or (2) the time and place of the reconvened meeting is announced at the above referenced meeting with no change to the agenda.

The application seeks a Special Use Permit for a commercial solar energy system with associated facilities (the "Project"). The Project is proposed to be located on approximately 2,382 acres of undeveloped land generally located south of South Beardstown Drainage Road, west of U.S. Highway 67, north of Berger Lane, and east of South Beardstown Drainage Road, further described below. The applicant has obtained leases, purchase options or other legal agreements from the owners of the specific properties described below to pursue this Project approval.

The applicant is Cass County Solar Project, LLC, a Delaware limited liability company, located at 422 Admiral Boulevard, Kansas City, Missouri 64106 ("Applicant Address"). The sole member (100% ownership) of the applicant is Savion, LLC, located at Applicant Address. Officers of the applicant are Rob Freeman, Geoff Coventry, Mark Alexander, Katie Gorman, Joel Ettinger, James Duff, James Gray, Jamie Marley, Ed Moore, Ron Rabkin and Scott Zeimetz at Applicant Address.

Project facilities are expected to include photovoltaic solar panels mounted on a single-axis tracking system along with associated infrastructure of electric inverters and transformers, underground electrical collection system, electrical collector substation, overhead transmission line, point of interconnection switchyard, an operations and maintenance building, battery storage, solar meteorological stations, SCADA hardware, control house for protective relay panels and site controllers, private access roads, security fencing and associated facilities. All Project facilities are proposed to be located on the following described property in Cass County: The West half (W½) of the Southwest quarter (SW¼) of the Southeast quarter (SE¼) of Section Twenty-nine (29) in Township Eighteen (18) North, Range Twelve (12) West of the Third Principal Meridian, Cass County, Illinois.
