CASS COUNTY BOARD MEETING

November 14, 2022

The Cass County Board met in the Courthouse, in the Courtroom, on Monday, November 14, 2022 at the hour of 7:00 P.M.

The meeting was called to order by Chairman Barnett, who directed the Clerk to call roll.

As a result of the roll call the Clerk states that all board members are present except for Hagloch.

Chairman Barnett declares there is a quorum.

Clerk Wessel states that it has been an honor to serve as the Clerk during Barnett's Chairmanship and that all citizen's in Cass County should be very thankful for Barnett's leadership and commitment in making Cass County a better place.

Clerk Wessel goes on to say it has also been a pleasure working with Bob Schaefer the past 20 years and wishes them both the best following their retirement from the board. Second Vice Chairman Bill Merriman next presents plaques to Chairman Barnett and Bob Schaefer for their years of service on the Cass County Board.

Chairman Barnett next states that serving as the Cass County Board Chairman the last 4 years has been the highlight of his life. Barnett states he is appreciative of the comradery of the board members. We stuck together during the pandemic and got through it. I am proud of what we have accomplished as a board over the last 4 years.

Chairman Barnett presents the minutes from the October 10, 2022 Cass County Board Meeting. Merriman moves to approve the minutes and Gibson seconds the motion. The vote is by acclamation and declared carried.

Chairman Barnett next calls for reports from the standing committees:

Noe, Chairman of the Courthouse and Jail Committee, reports the committee met on November 10, 2022 and approved all bills.

Road and Bridge Committee, reports the committee met on November 7, 2022 and approved all bills.

Merriman reports Public Safety met on October 24, 2022

The Animal Control Commission met on October 20, 2022, but did not have a quorum.

Cass Rural Water met on October 18, 2022. Craig Myers attended the meeting and the board reviewed the audit.

Hance, Liaison of the Health Department Board, reports that Andrew English went to work for the Illinois Department of Public Health and Delaney Sieving will take Andrew's place. The Health Board would like to hire 2 full-time Health Educators. There is also a need for Hospice volunteers.

Starkey, Liaison for Transit, reports that they are switching to The First National Bank of Arenzville.

Transit provided safe rides in Beardstown on Halloween.

Chairman Barnett, reporting for the Finance & Judiciary Committee, reports the Fiscal Year 2022-2023 Cass County Budget and Levies will be presented for approval under new business.

Merriman, Chairman of the Supervisor of Assessments Committee, reports the committee met on October 19, 2022. There is not much going on right now. The next meeting will be held on Monday, November 21, 2022, at 6:00 p.m.

Schaefer, Liaison for MCS reports that 2400 applications have been processed for the LIHEAP Program. Shaefer also reports that the Homeless Prevention Service Program and the Emergency Transitional Housing Program are out of funds.

Schaefer, Liaison for the Arenzville Rural Water Board, reports they had an 8% loss last month. The board hopes the water for Phase 3 will be turned on this month.

Noe reporting for OEDC, states that Mayor Harris reported that the Tractor Supply Store in Beardstown will be opening on December 3, 2022.

There was one TIF application in Virginia submitted by Sarah Fanning. Sarah plans on opening up a business on the Virginia square.
