CASS COUNTY BOARD MEETING

February 14, 2022

The Cass County Board met via teleconference, on Monday, February 14, 2022 at the hour of 7:00 P.M.

The meeting was called to order by Chairman Barnett, who directs the Clerk to call roll.

The Clerk calls roll.

As a result of the roll call the Clerk states that all board members are present.

Chairman Barnett declares there is a quorum.

Chairman Barnett now leads the board in the Pledge of Allegiance.

Teresa Armstrong of the Cass County Health Department, presents an update on the latest information related to the Coronavirus Covid-19 Pandemic. Armstrong states that Cass County is in a much better place. The number of active cases went from 345 in one week to only 30 active cases as of today. The number of hospitalizations has also improved.

The Health Department is still offering 2 vaccination clinics per week.

Cass County has had 51 fatalities and there is currently 1 person in the hospital.

Schools are doing much better but still conducting the "Test to Stay"

The Health Department continues to offer clinics weekly alternating between offices in Virginia and Beardstown, as well as the pop-up clinics throughout the county. The fully vaccinated rate for Cass County is 58.55%.

Armstrong states that the state mask mandate ends on February 28, 2022.

Chairman Barnett next presents the minutes of the January 10, 2021, Cass County Board meeting for approval. Merriman moves to approve the minutes and Noe seconds the motion. The vote is by acclamation and declared carried.

Noe, reports the Courthouse and Jail Committee met on February 10, 2022, and approved all bills as presented.

Merriman, reporting for the Road and Bridge Committee, reports the committee met on February 7, 2022 and approved all bills. Icenogle praised his crew for the snow removal.

Merriman reports the Animal Control Commission met on January 27, 2022. Mayor Harris and County Board Chairman Barnett attended the meeting. Merriman states they are searching for a location in Beardstown for Animal Control.

Merriman reports the Supervisor of Assessments Committee met on January 24^{th.} The assessments for Newmansville Township were left out of the publication in the Cass County Gazette. The date to publish was extended and the deadline to file complaints was extended to February 19th. The Assessor's office have received 30 complaints to far. The next meeting will be held on Monday, February 28, 2022, at 6:00 p.m. Hagloch reports E-9-1-1 met remotely on January 24, 2022 and approved all bills.

Schaefer reports Arenzville Rural Water met on January 18, 2022. A 12% water loss was reported.

Wessel attended the Cooperative Extension meeting in Carrollton on February 10, 2022. Cass County has the second highest number of new 4-H members. The next meeting will be held in Winchester on March 24, 2022.

Chairman Barnett reports that BLH Computers will be conducting a county wide electronic cleanup on Saturday, March 26, 2022 from 9:00 a.m. to Noon in each community in Cass County.

Barnett would like one county board member and one community representative to be present at the drop off location to make sure only Cass County residents are participating in the free service. Residents living outside of Cass County may drop off their electronics for a \$20 fee.

Barnett next reports that Scott Lummis has accepted a position in Quincy. Lummis has submitted a letter of resignation as Cass County Death Examiner effective February 28, 2022.

Barnett reached out to Sheriff Devron Ohrn about filling the position of Interim Death Examiner and Sheriff Ohrn is willing to accept the position.

The Chairman now moves on to New Business:
