The Cass County Board met in the Courthouse, in the Courtroom, on Monday, December 12, 2022 at the hour of 7:00 P.M.

The meeting was called to order by Chairman Barnett, who directs the Clerk to call roll.

As a result of the roll call the Clerk states that all board members are present except for Hagloch.

Chairman Barnett declares there is a quorum.

Chairman Barnett now leads the board in the Pledge of Allegiance.

Chairman Barnett states that Brian Dickerson of BLH was supposed to send the agreement for the 2023 Electronics Pickup. The agreement will be presented to the new board for approval once it is received.

Chairman Barnett appoints French, Starkey, and Noe to the Committee on Credentials. The committee moves to the jury room to review the election results. After a short recess, the Committee on Credentials reports that on examination of credentials, as was submitted by the Election Authority, reveals that 11 persons were duly elected at the November 8, 2022 General Election and that they are qualified in all respects, to serve as Cass County Board Members. Schaefer moves that the new members credentials to serve be accepted by the board and Starkey seconds the motion. The vote is by acclamation and declared carried.

At approximately 7:05 p.m. with no other business to take place. Wessel moves that the old board adjourn "Sine Die" (which means without a day) and Hagloch seconds the motion. The vote is by acclamation and declared carried.

At approximately 7:06 p.m. the County Clerk, Shelly Wessel, calls the meeting to order as Statutory of the Board.

Sheriff Ohrn declares the Cass County Board is now in session. The Clerk calls roll.

As a result of the roll call the Clerk states that all members are present except for Ruppel.

The Clerk states that the next order of business shall be the selection of a Temporary Chairman to preside until the election of a Permanent Chairman. County Clerk Wessel asks for nominations to elect a Temporary Chairman of the Cass County Board. Douglass nominates Bill Merriman and French seconds the nomination.

A motion to close the nominations and elect Bill Merriman as Temporary Chairman is made by Noe and seconded by Douglass. The vote is by acclamation and declared carried.

Now, Merriman acting as Temporary Chairman, states the first order of business would be receiving nominations for Permanent Chairman, to serve for a two-year term of office.

Wessel nominates Merriman for Permanent Chairman and French seconds the motion. A motion to close the nominations and elect Merriman as Permanent Chairman is made by French and seconded by Starkey. The vote is by acclamation and declared carried.

Chairman Merriman states the next order of business is to elect a Vice Chairman of the County Board. Douglass nominates Wessel and Starkey seconds the motion. A motion to close the nominations and elect Wessel as Vice Chairman is made by Noe and seconded by French. The vote is by acclamation and declared carried.

Chairman Merriman next asks for nominations for Second Vice Chairman. Gibson nominates Douglass and French seconds the motion. A motion to close nominations and elect Douglass as Second Vice Chairman is made by Wessel and seconded by French. The vote is by acclamation and declared carried.

Chairman Merriman next presents the Standing Committees for approval. Wessel moves to approve the committees and Douglass seconds the motion. The vote is by acclamation and declared carried.
